Resources for Persons With Diabetes Who Are Unemployed and Without Health Insurance

During this economic downturn, persons with diabetes who are without jobs and health insurance will find the following ideas for obtaining resources helpful. These ideas are also relevant for anyone having challenges in meeting basic diabetes expenses. Please pass these on to your patients, family and members of the community:

- Apply to the patient assistance program of the company that makes the patient's insulin, using the reason of "hardship needs." All of the companies have patient assistance programs. Ask the pharmacist for information on the company and then call or email them for medication assistance information.
- Contact the American Diabetes Association (www.diabetes.org or 800-342-2383) or the Juvenile Diabetes Research Foundation (248-355-1133 in southeast Michigan or 616-957-1838 in west Michigan) to see if they have any local assistance programs.
- Contact the primary physician who may be able to help out if they have any free supplies or "samples" in their office. The physician may also agree to have a discussion about less expensive regimens.
- Contact a local Diabetes Self-Management Education (DSME) program to see if the certified diabetes educator (CDE) is aware of any local resources or has some stop-gap supplies. A visit with the CDE might help in learning how to reuse supplies or tweaking of regimens. A local hospital may also have a patient assistance/scholarship program if the patient obtains his supplies through their pharmacy. For a listing of the DSME programs in a given area, visit www.michigan.gov/diabetes and click on the link to the DSME programs.
- Visit the Michigan Diabetes Outreach Network's (MDON) website www.diabetesinmichigan.org. This site identifies the six regional DONs with their contact information. Each DON has a resource directory posted on the website with information on resources in the area, including support groups. Joining a support group may provide information from others who have had to deal with similar issues. Most also include information on medication assistance and supplies. Call your regional DON for more specific information and to discuss options.
- Contact your legislators to ask for assistance and to increase their awareness of the need for access to health care services for those who are uninsured or underinsured.
